Silver Creek Hunting Club Rules 2025-2026

General Rules

 All members must have a valid Silver Creek Hunting Club membership card on his / her person and accessible to show to a fellow member while on the club's property.

2 Club members are required to display a current vehicle pass on vehicles and an ATV sticker must be visible on ATV's. Vehicles and ATVs without a visible vehicle pass (sticker) are subject to being towed at the owner's expense.

Guests are not allowed...except for your spouse, your child and/or your grandchildren under the age of 19. A club member must be present when bringing the above mentioned

guests.

- 4. If a child kills a deer, both the club member and child must sign-out the deer.

 Children must abide by the club's harvest rules unless the deer is the child's "first ever"

 Deer harvested.
- 5. Only Club members can work on club properties. Unless approved by club president ..
- 6. Club membership dues for 25/26 are \$800.00 which includes a spouse membership.
- 7. Our club membership year starts March 1st and ends February 28th of the following year. Membership slots are filled on a first paid basis. New members will be accepted based on available (open) membership slots.

Deer Harvest Rules

- Georgia DNR (state) hunting regulations apply to all club properties. Additional club restrictions also apply.
- 2. Georgia DNR (state) Game Rules Tracts

Bailey Road and Haywood Valley - Georgia DNR game laws and deer harvest rules apply. A maximum of two (2) doe per membership, one of the allowed doe must be harvested with a bow or muzzle loader.

New Club Rule - Bucks Harvested must have a minimum of 6 points.

3. Quality Managed Tract

a. Watkins Gin - Bucks harvested at Watkins Gin must have a minimum 15" inside spread or 16" for both main beams.

A maximum of one (1) doe per membership - may be harvested.

That doe must be harvested with a bow or muzzle loader.

- b. Hunting (harvesting) doe on a club food plot or another member's food plot is not allowed.
- c. Both the hunters and doe must be 100 yards away from the food plot. Exception, children under the age 16 can harvest a "first ever" doe or buck on a club food plot.
- d. Bucks harvested on a "Quality Managed Tract" must be shoulder or European mounted. The name, address and phone number of the licensed taxidermist mus be provided. All deer must be signed out at the gate on the day of the kill.

- e. A PICTURE AND JAW BONE OF ALL BUCKS HARVESTED ON THE CLUB MUST BE SENT TO A CLUB OFFICER WITHIN 14 DAYS OF KILL. Additionally, also send a copy of picture To info@silvercreekhuntingclub.com (David Warren and David Glover will receive.)
- f. Hunter's harvesting a buck that doesn't meet the minimum requirements for the "Quality Managed Tract" will be fined \$200.00 and will not be allowed to hunt until the fine is paid. After the fine is paid, second buck may only be harvested on another tract.

Small Game Hunting Rules

- **1. No** Guests Allowed..except a spouse or your child under age 19. A club member must be present with the child (children) while on club property.
- 2. Small game hunters are not allowed to release dogs any closer than 300 yards from other hunters. Hunters are limited to 6 rabbits per day. Coon hunters may not hunt Until 1 hour after sunset and must leave by 3am. Only 3 coons are allowed per tract of land, per season, per member.
- 3. If applicable planted dove fields will be fully open to Dove hunt during Deer season.
- 4. All State game laws apply.

Sign-in Rules

- All members must mark the sign-in board map (of the appropriate property) while visiting or hunting a property.
- 2. You must sign-in when you arrive and sign-out when you depart.
- 3. Do not erase another member's markings on sign-in board/map.
- 4. The sign-in board shall not be marked over 24 hours in advance.

Land Management

- **1.** No cutting of trees.
- 2. All members must do one of the following:
 - a. Plant a food plot.
 - b. Put out a feeder & keep it full (member's name must be visible on all feeders)
 - c. Put out minerals.
- 3. All members must attend a club workday.
- 4. You must provide the appropriate club officer with details regarding your work on tract.
- All feeders, feed, and visible traces of minerals must be removed 14 days prior to Turkey season.
- **6.** Food plots and feeders must be approved in advance by club officer responsible for that track of land.
- 7. If you place a feeder it must be actively managed with a mix of corn and high protein feed.
- 8. Any camper(s) on properties can only be on the property 2 weeks prior to deer (bow) season and must be removed by 2 weeks after deer (rifle) season

Stands

- 1. Stands may not be placed over another member's food plot or feeders.
- 2. Stands will not be nailed to trees.
- **3.** All stands, feeders, and personal property must be marked at eye level with the year, member's name & phone number.
- **4.** Stands on power lines & gas lines are not to extend no more than 3 feet onto right of way and must be on the same side as all other permanent stands.
- **5.** If you have a stand, you must maintain your stand year-round and visit each stand on a monthly basis.
- **6.** If you have a permanent stand on that piece of property you may only hunt another members stand if you've contacted and gotten permission beforehand.
- 7. Members will only possess 2 stands on Haywood Valley property.
- 8. Any and all safety restraints shall be required while climbing stands.
- 9. Do not hunt another members' stand unless you have a permanent stand on the same tract and visited that tract once per month..
- 10. If you harvest a deer from another members stand/food plot, you are not allowed to hunt that members stand/food plot again during the current hunting season.
- **11.**Hunting (harvesting) doe on club food plot or another members feeder or food plot is not allowed.
- **12.** Any stands on **Haywood Valley property (only)** the GPS pin must be given to Bob Halliday, Club Officer for Haywood Valley property.

Feeders

- 1. All stands, feeders, and personal property must be marked at eye level with year, member's name & phone number.
- 2. We recommend that the feeder activation time be set for 9:00am and 4:00pm.
- **3.** Corn and feed must be removed from feeders by the end of February and may be returned after Turkey season.
- 4. Feeders must be maintained and in place by September 1st.
- **5.** If you come across another members feeder do not tamper or mess with if it's not yours.

Rule of conduct

- 1. No shooting over an adjoining landowner's property.
- 2. Approved "Sight-in" area for rifles will be designated by officers of that tract of land.
- 3. Sight-in rifles prior to opening day of Deer (archery) season (Sight-in is not allowed after opening day)
- **4.** A safe distance must be maintained between hunters during Deer season; 150 yards during archery (only) season and 300 yards during gun season.
- **5.** If you see someone trespassing, try to get their name and picture. Call 911 and ask for a game warden then report the event. Provide details to a club officer including date and time.
- 6. Members are asked to carry some kind of camera.
- 7. NO JOY RIDING ON THE CLUB'S PROPERTY DURING HUNTING SEASON.
- 8. No riding through food plots.
- 9. Anyone caught playing in mud, tearing up property or roads; anyone caught breaking State Game Laws or caught breaking club or lease rules will be kicked out of the club With no refund...

No one under the influence of alcohol or a controlled substance is allowed on the Property at any time!! No alcohol or controlled substance is allowed on the property at any time!! Anyone caught is automatically dismissed from the club!!
